- Employer
- Recruitment Agency
- Sub-Contractor
- Or any form of employment including employment by another another Craft Worker

### And it is also binding on All Construction Workers / Apprentices

- Employed directly
- Employed indirectly
- Self-employed (C-45 or RCT-1)

Note; Apprentices must be registered with SOLAS within 2 weeks of commencing employment. There should be no pre-apprenticeship probation. Probationary period should be included in four year apprenticeship

#### **OVERTIME RATES**

#### Monday To Friday;

From normal finishing time to midnight – time plus a half. Midnight to normal starting time – double time.

#### Saturday & Sunday;

First four hours Saturday – time plus a half. Thereafter double time to normal starting time on Monday.

#### **HEALTH & SAFETY**

All Workers are required to hold an up to date SAFEPASS Card and a Manual Handling Certificate. Employers must provide this training and paid release for All Workers to attend during working hours.

#### TRAVEL TIME & SUBSISTENCE

Agreement is in place to pay expenses to all Construction Workers in Dublin, Cork Limerick, Waterford and Galway. Other areas are subject to negotiation.

Travel time should (where applicable) be included when calculating holiday pay.

Subsistence Allowance (Country Money) shall be €181.68 per week for 5, 6, or 7 days and 1/5th the value per day for 4 days or less (Subsistence may be liable to Revenue deductions).

# SICK PAY/PENSION & MORTALITY SCHEME

All Construction Workers / Apprentices (between the ages of 20 years and 65 years of age) must be entered into a scheme which provides the benefits of Sick Pay/Pension and Mortality payments.

This is typically known as the Construction Workers Pension Scheme and both Employer & Employee must pay into it as a weekly deduction.

Deductions for the Pension Scheme should be shown on your payslip. It is important that you ensure your Employer passes these contributions on to the Scheme, so that you are in benefit to claim sick pay or mortality benefit (for your dependants). See www.cwps.ie for further details.

Note; The TEEU also provides additional insurance benefits to members.
